▶ Road Traffic Accidents

Have you have been injured in a car accident which was not your fault? If so, you could be entitled to compensation. We can advise drivers, passengers and pedestrians on a range of injury claims, from minor whiplash, cuts and bruises to serious brain injury.

If you make a successful claim, the compensation will usually be paid to you by the insurance company of the driver at fault. However, even if the driver at fault was not insured or cannot be traced, we can still help you to make a potential claim under the Motor Insurance Bureau Scheme.

▶ Accidents at Work

We can advise you on making a claim for a full range of occupational accidents or illnesses.

According to the Labour Force Survey, 274,000 reportable workplace injuries occurred in 2006-7. Employers are responsible for providing a safe working environment and will be liable for any claims which result from any failures to adhere to health and safety rules. If you have suffered an accident at work, whether tripping over some loose carpet or being injured by faulty machinery, you could be entitled to compensation.

▶ Slips and Trips

Have you suffered an injury as a result of a slip or trip in a public place? If so, you may be entitled to compensation.

We have a wealth of experience regarding claims for a range of injuries which result from slips and trips - minor bruises, broken bones or worse. Contact us for advice on making a claim - whether you have tripped over loose pavement in the street or slipped on some spilled milk in a supermarket.

▶ Sports Injuries

▶ Defective Products

▶ Holiday Accidents
